The Trials are sanctioned by the United States of America Wushu-Kungfu Federation Inc. (USAWKF) and organized by Malee’s School of Tai Chi & Kung Fu. Hereafter, USAWKF and Malee’s School of Tai Chi & Kung Fu collectively are referred to as “the Organizing Committee.” I hereby assume all risk of physical and mental injuries, disabilities, and losses, which may result from or in connection with my participation in the trials. I fully understand that any medical attention or treatment afforded to me by the Organizing Committee will be of the first aid type only. Acting for myself, heirs, personal representatives, and assignees, I do hereby release and forever discharge, and agree to indemnify and hold harmless the State of Connecticut, Eastern Connecticut State University, the Organizing Committee, and their officers, agents, officials, judges, representatives, servants, employees, volunteers, sponsors and all other related members from all claims, actions, suits, and controversies at law or in equity by reason of any matter, cause, or thing whatsoever that I may sustain as a result of or in connection with my participation in the trials or use of Eastern Connecticut State University equipment and facilities including travel thereto and therefrom, whether due to the negligence, omission, default or other action of any person or entity. I also understand that participation in the Trials, especially but not limited to fighting point or full contact sparring matches, entails a great risk of injury, and I assume full responsibility for all of my actions, intentional or otherwise, during and in connection with my participation in the trials. I agree that my performance, attendance, and participation at the Trials may be filmed or otherwise recorded or telecast live. I consent to the use by the Organizing Committee of my name, likeness, voice, poses, pictures, and biographical data concerning fully or in parts, in any form or language, with or without other material, throughout the world, without limitation, for television, radio, video, theatrical motion pictures, or any other medium by devices now known or hereafter devised, and I do hereby waive any compensation in regard thereof as well as any future rights to the aforementioned. I understand that the rules and regulations applicable to the USAWKF and the International Wushu Federation (IWUF) are designed, in part, for the safety and protection of participants.
